### Rationale for the revised fees

#### **Changes to Base Fee**

- The fee for Affiliates, Out of Country, Seniors, Sustaining And Special Circumstance member classes has been altered to consistently represent 2/3 of the Active member fee.
- The reduced fee for Active 1st year at 50% of the Active fee remains the same but is applicable only to Residents entering their first year of practice.
- The Out of Country member class (without Canadian Family Physician) is being discontinued.
- Initially, the Royal College and CFPC had established a 'Non-Member-Mainpro Participant (NMMP)' fee that was approximately the same percentage of each College's active member fee. Since that time, the Royal College moved to a fee that was equal to approximately 75% of the active member fee and is currently set at \$600. CFPC is now proposing this fee to be at 75% of the Active Member fee.
- The 2nd and 3rd year Residents receive extraordinary value through access to Mainpro, Canadian Family Physician, networking options, access to First Five Years in Practice Facebook page, and discounts at Family Medicine Forum. While the value of this membership has

increased substantially with additional programming, no significant change to the fee has been made for many years.

## COLA:

The Base fee has been adjusted by the Cost of Living Adjustment (Inflation) rate of 3%.

#### **Impact of Mainpro+ Platform:**

- An increase of \$28 related to the new Mainpro+ Platform maintenance fees per user is included
  in the proposed fee for NMMP and for the following membership classes: Active, Active 1st
  year, Out of Country, Senior, Sustaining and Special Circumstances.
- Although the new platform is available to residents, the annual maintenance fees per user have been forgiven by the vendor and hence no additional cost is added to the fee for this class.
- Although available to Life and Affiliate members, the annual maintenance fee for these groups
  has been absorbed in the overall budget and no fee increase related to the Mainpro+ Platform
  for these member classes have been proposed.
